WHEREAS, per Ohio Revised Code Section §121.22, concerning open public meetings, it is required that this Board adopt rules relative to scheduling special and special Board meetings and providing notice of these meetings, NOW THEREFORE BE IT RESOLVED, By the Board of Commissioners of Ashtabula County, Ohio:

1. Pursuant to Ohio Revised Code §305.06 the Board of Commissioners shall conduct at least fifty (50) regular sessions each year and further that said sessions shall be conducted at a specific time set in advance.

4. The Ashtabula County Board of Commissioners hereby establishes reasonable notice for special sessions of the Board by posting said notice on the Ashtabula County Website at www.ashtabulacounty.us and via email to members of the local media, including the Star Beacon, Gazette Newspapers, and Media-One.
5. Special and emergency sessions will be held at the call of the Board.
6. The Clerk of the Board shall give notice to the media of the date, time, location and purpose of a special session no later than twenty-four hours before the meeting is to start, or, if not possible, as soon as the special session has been called.
7. Any person may obtain reasonable advance notification, with payment of a reasonable fee if warranted, of all meetings at which any specific type of public business to be discussed and may be contacted via telephone, special mail or email by submitting a written request to the Clerk of the Board specifying the person's name, address, telephone number and/or e-mail address, along with the specific type of public business that is of interest, and the amount of time this request covers (not to exceed three months).

RESOLUTION NUMBER 2020-3 ORDERING COUNTY ENGINEER TO EMPLOY LABOR AND PROCEED BY FORCE ACCOUNT TO MAINTAIN AND REPAIR ROADS, BRIDGES AND CULVERTS, AND TO ERECT NECESSARY SIGNS IN ASHTABULA COUNTY FOR 2020

The Board of County Commissioners of Ashtabula County, Ohio, met on the 7th day of January, 2020, in special session at the offices of said Board, 25 West Jefferson Street, Old Courthouse, 2nd Floor, Jefferson, Ohio, with the following members present: J. P. Ducro IV, Casey R. Kozlowski, Kathryn L. Whittington.

WHEREAS, THE Board of County Commissioners has decided that the health, welfare and safety of the people of Ashtabula County can best and most efficiently be served by the "Force Account" in matters pertaining to the construction, reconstruction, improvement, maintenance, or repair of Ashtabula County roads, bridges and culverts, in accordance with the Ohio Revised Code, as follows:

5543.19 (A) The county engineer may, when authorized by the board of county commissioners and not required by this section or other law to use competitive bidding, employ such laborers and vehicles, use such county employees and property, lease such implements and tools, and purchase such materials as are necessary in the construction, reconstruction, improvement, maintenance, or repair of roads by force account.

In determining whether construction or reconstruction, including widening and resurfacing, of roads may be undertaken by force account, the county engineer shall first cause to be made an estimate of the cost of such work using the force account project assessment form developed by the auditor of state under section 107.16 of the Revised Code. When the total estimated cost of the work exceeds thirty thousand dollars per mile, the county commissioners shall invite and receive competitive bids for furnishing all the labor, materials, and equipment necessary to complete the work in accordance with sections 307.86 to 307.92 of the Revised Code.

(B) The county engineer may, when authorized by the board of county commissioners and not required by this section or other law to use competitive bidding, employ such laborers and vehicles, use such county employees and property, lease such implements and tools, and purchase such materials as are necessary in the construction, reconstruction, improvement, maintenance, or repair of bridges and culverts by force account.

In determining whether such construction, reconstruction, improvement, maintenance, or repair of bridges or culverts may be undertaken by force account, the county engineer shall first cause to be made an estimate of the cost of such work using the force account project assessment form. When the total estimated cost of the work exceeds one hundred thousand dollars, the board of county commissioners shall invite and receive competitive bids for furnishing all the labor, materials, and equipment necessary to complete the work, in accordance with sections 307.86 to 307.92 of the Revised Code. The county engineer shall obtain the approval required by section 5543.02 of the Revised Code.

© "Force account," as used in this section means that the county engineer will act as contractor, using labor employed by the engineer using material and equipment either owned by the county or leased or purchased in compliance with sections 307.86 to 307.92 of the Revised Code and excludes subcontracting any part of such work unless done pursuant to sections 307.86 to 307.92 of the Revised Code.

The term "competitive bids" as used in this section requires competition for the whole contract and in regard to its component parts, including labor and materials. Neither plans nor specifications shall be drawn to favor any manufacturer or bidder unless required by the public interest.

THEREFORE BE IT RESOLVED, that the Board of County Commissioners, of Ashtabula County, Ohio, does hereby authorize the Ashtabula County Engineer to use the existing county employee forces and proceed by "Force Account" in the construction, reconstruction, improvement, maintenance, or repair of roads, bridges and culverts as determined by the County Engineer in Ashtabula County during the year 2020.

- Adopt, publish and enforce rules authorized in the solid waste management plan.
- Designation of solid waste facilities where solid wastes generated within or transported into the district must be taken for disposal, transfer, resource recycling or recycling.
- Establish contracts for solid waste collection, storage, transfer, disposal, recycling, processing, or resource recovery services.
- Establish contracts for the collection of district generation or disposal fees.
- Prosecution or civil action against violators.
- Require county sanitary engineer to prepare a general solid waste facility plan.
- Issue bonds to pay for acquisition, construction, enlargement, modification or repair of any improvement.
- Establish rates or charges on premises to which solid waste collection, storage, transfer, disposal, recycling, processing or resource recovery is provided by the district.
- Prepare, adopt, submit for approval to the Ohio EPA and implement a solid waste management plan.
- Establish and convene a policy committee
