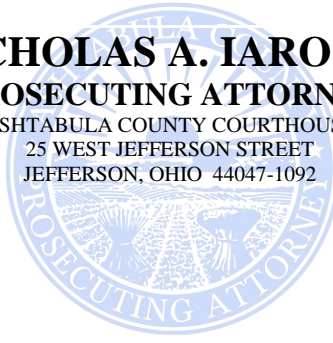

On March 19, 2019, the Ashtabula County Grand Jury directly indicted the following persons:

TRAVIS E. BURDETTE

1. One count of **Felonious Assault**, a second degree felony
2. One count of **Involuntary Manslaughter**, a third degree felony
3. One count of **Improperly Handling Firearms in a Motor Vehicle**, a fourth degree felony
4. One count of **Aggravated Menacing**, a first degree misdemeanor
5. One count of **Disorderly Conduct**, a minor misdemeanor

DAKOTA BURDETTE

1. One count of **Complicity to Felonious Assault**, a second degree felony
2. One count of **Involuntary Manslaughter**, a third degree felony
3. Two counts of **Improperly Handling Firearms in a Motor Vehicle**, each of which is a fourth degree felony
4. One count of **Carrying Concealed Weapons**, a fourth degree felony
5. One count of **Aggravated Menacing**, a first degree misdemeanor
6. One count of **Disorderly Conduct**, a minor misdemeanor

CHRISTOPHER ALSTON

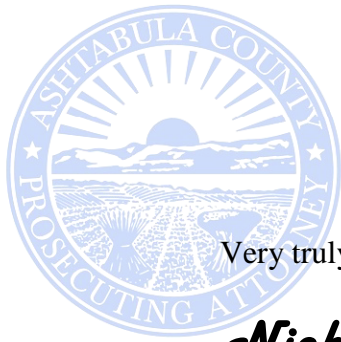
1. One count of **Having Weapons While Under Disability**, a third degree felony
2. One count of **Tampering with Evidence**, a third degree felony

The charges stem from the January 24, 2019 shooting death of Jerome L. Noble at Circle K on Main Avenue in the City of Ashtabula. The investigation was conducted by the Ashtabula Police Department and the Bureau of Criminal Investigation (BCI).

Travis Burdette and Dakota Burdette were arrested without incident on March 21, 2019. Christopher Alston has been in custody since the date of the incident on January 24, 2019. All three are currently incarcerated in the Ashtabula County Jail. Arraignments will be scheduled before Judge Gary L. Yost in the near future.
